SWIMMING ABILITY

Ski Level	Examples of ability for this level include
Snowgarden	Complete beginner – never skied before
Blue Prince	Can put on, take off & carry own skis; stepping uphill, gliding and braking with the snow plough, slow snow plough turns
Blue King	Can traverse with skis parallel, side-slipping, snow plough turns on an easy blue slope
Blue Star	Can follow instructor in a line, can link turns on a versatile blue run to control speed, half turns in snow plough finishing parallel. Skiing over bumps
Red Prince	Braking with skis parallel, turning steps on an easy slope. Confident on red runs, skidded parallel turning
Red King	Confident with speed on groomed terrain, short turns on an easy slope, skating steps, basic air (small kicker), parallel turns with various radius on red runs
Red Star	Parallel turns through slalom gates, single ski turns on an easy slope, short turns on red runs
Black Prince	Short turns with pole planting on a difficult slope. Jumps. Skiing with skis parallel with steps and tricks, carved parallel turns

Please bear in mind this is just a guide for our first day's ski groups and the expertise of our instructors ensures children are quickly placed in groups with skiers of similar abilities with changes occurring throughout the first two days. For those who skied with us last year please also inform us of how many additional weeks skiing has been done between Davos 2017 and the 2018 trip.

PERMISSION FOR UNACCOMPANIED PUPILS TO LEAVE HOTEL PREMISES OR SWIM WITH OTHER SKI TRIP FAMILIES.

Permission for your child or children to be taken out by other Dragon parents. Typically, this might arise when unaccompanied children are asked out by an accompanied friend and their family to join them for a swim, trip for a hot chocolate, visit to the shops or for an evening meal away from the hotel. We will only release children into the care of others if we have your written permission. This would not be giving permission for your child to go skiing with another family as we feel this would still require your verbal permission. We would ask parents to inform you if and when your child is invited out in such circumstances.

By returning the form, you acknowledge that responsibility for your child or children will pass from the Dragon Staff to the adult in whose company the child leaves the Hotel premises or enters the pool until the child is returned. If you do not return the form we will assume that you do not give your permission for your child or children to leave the hotel with anyone other than a Dragon member of Staff.

Finally, the Dragon Staff may use their discretion, on behalf of the Ski Club, to refuse permission for children to leave the hotel premises in the care of an adult other than their parent or guardian, even when parental permission has been given. If they do so, they will endeavour to contact you straight away to explain the circumstances.
